In 2018 he accepted a guest professorship at in the law school at **Beiwai University** in Beijing, and lived in China as a resident lecturer for several months.

In 2011 he received the **Hawaii State Bar Association**'s Greeley-Key Award for Innovation in the Law, recognizing his work on forgiveness projects and restorative justice. In the same year was listed as the best tax attorney in Hawaii, by **Best Lawyers in America**.

Michael North, Managing Member of APG, is also Chairman of Galaxy Trade and Technology, a leading supplier of magnesium and allied products to world markets.
